Must have a passport or an
equivalent document

REQUIREMENTS for the FOREIGN CITIZENS

Flat-rate contribution of
500 euros paid by the employer using the
F24 REDT 2020 form

tax stamp of 16 euros

In case of declaration of existence
of an employment relationship
flat-rate contribution for
the sums due to the employer as
remuneration, contribution and taxes.

Residence permit for **SUBORDINATE EMPLOYMENT**

with a max duration of 2 years according to the duration
of the contract and renewable after its expiry date

BEFORE 31 OCTOBER 2019 THE

Post Office kit to be sent to the Police
Headquarters (Questura) through
sportello amico (Poste Italiane)

After that, the person receives a notice of
meeting to the Police Headquarters (Questura),
for the photo ID registration and "EMERS 2020"
receipt, that allows to stay legally in Italy
and work in the provided sectors.

flat-rate contribution of **130 euros**
paid by the applicant using the
F24 RECT 2020 form

tax stamp of 16 euros

Temporary residence permit

in paper, valid for 6 months and not renewable, convertible
in working permit with a contract in the provided sectors

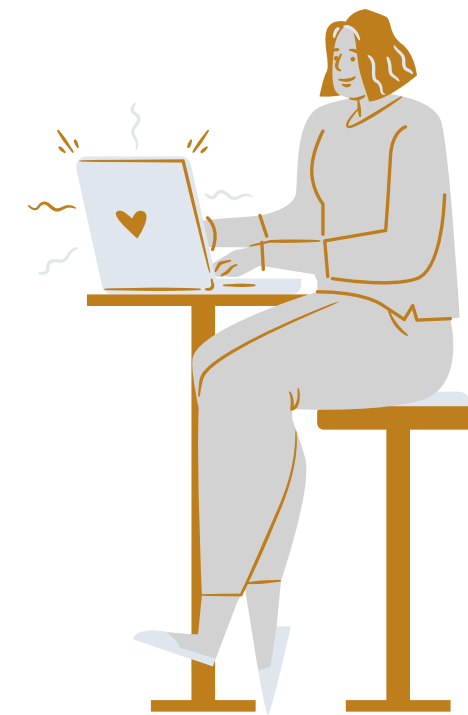

REQUIREMENTS for the EMPLOYERS

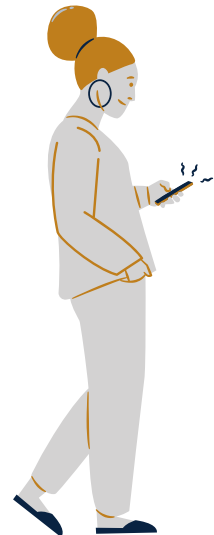
PAR. 1

- ITALIAN CITIZENS, EU CITIZENS OR FOREIGN CITIZENS OWNING A EU LONG-TERM RESIDENCE PERMIT OR RESIDENCE CARD FOR EU CITIZENS' FAMILY MEMBERS
- WITH REGARDS TO AGRICULTURE, BREEDING, FISHING, ETC., THE APPLICANT MUST HAVE A REVENUE OR MINIMUM INCOME OF 30,000 EUROS PER YEAR.
- WITH REGARDS TO HOUSEWORK, THE APPLICANT MUST HAVE A MINIMUM INCOME OF 20,000 EUROS (AN INCOME-EARNER) OR 27,000 EUROS (MORE THAN ONE INCOME-EARNER)
- THE VERIFICATION OF THE INCOME REQUIREMENTS IS NOT APPLIED TO THOSE EMPLOYERS WITH PATHOLOGIES OR DISABILITIES THAT IMPAIR THEIR SELF-SUFFICIENCY WHO PRESENT THEIR APPLICATION FOR FOREIGN CITIZENS THAT WORK AS THEIR CARETAKERS.



WORKING SECTORS

- AGRICULTURE, BREEDING AND ZOOTECHNICS, FISHING, ACQUACULTURE AND RELATED ACTIVITIES
- CARETAKING OR ASSISTANCE TO THE PERSON FOR ONESELF OR FAMILY MEMBERS, EVEN NON-COHABITANTS, WITH PATHOLOGIES OR DISABILITIES THAT IMPAIR THEIR SELF-SUFFICIENCY
- HOUSEWORK THAT SUPPORTS FAMILIAR NEEDS
