New immigration regulations

Two important laws have recently been approved which introduce significant changes on some types of residence permits. The main aspects are described below.

The first law is the new decree of flows

For the first time in many years, quotas are provided for the entry of NON-seasonal workers. Exactly 6,000 quotas that will correspond to as many renewable residence permits for subordinate work.

In particular, they will be able to bring workers who will be employed in the road haulage, construction and tourism-hotel sectors.

It will also be possible to convert 4060 residence permits for seasonal work into residence permits for reasons of subordinate employment, in addition to these quotas, a further 1500 are foreseen for the conversion of residence permits for study, internship and/or professional training. In the end, 500 quotas are anticipated for self-employment.

The second news is the approval of the Decree Law 21st October 2020

The regulation introduces many innovations in the field of immigration, international protection and the hospitality system.

In particular, it will be possible to convert to work some types of residence permits that previously could not be converted; these are permits for:

- Special protection
- Calamity
- Assistance for minors
- Sporting activity
- Artistic work
- Religious reasons
- Elective residence
- Expected acquisition of citizenship

News are also foreseen for the issuance of a residency permit for medical treatment; it will be easier to obtain it, those who will enter with a visa for medical treatment will be authorised to work.

Furthermore, the continuation of the stay in Italy of unaccompanied foreign minors who turn 18 will be allowed even if the Committee for Minors does not make a decision.

The possibility for asylum seekers to be registered in the registry office and to obtain an identity card will again be sanctioned by the law.

SIPROIMI, Protection system for holders of international protection and for unaccompanied foreign minors, (SIA), Support for Active Inclusion, will once again be able to receive asylum seekers. Lastly, the deadline for the definition of citizenship application procedures is taken from 48 months to 36 months.
