**#CORONAVIRUS ANTI-COVID PROVISIONS**

New Decree of the President of the Council of Ministers Giuseppe Conte in effect

from 6th November until 3rd December

**RAVENNA IS IN THE YELLOW AREA**

**THIS MEANS:**

**→ MOVEMENT**

From 10 p.m. to 5 a.m. it is forbidden to leave the house except for work, necessity or health reasons, therefore it is necessary to have the self-certification form with you.

In any case, it is strongly recommended, for the remaining of the day, not to move around by public or private transport, except for work, study, health reasons or situations of need.

**→ STREETS AND SQUARES**

The streets and squares may be closed to the public

**→ SCHOOL**

The activities of nursery, primary and secondary schools and for educational services for children will continue to take place in presence.

Distance learning instead in high school.

This is without prejudice to the possibility of in-presence activities where the use of workshops is necessary or to ensure the effective inclusion of students with disabilities or special educational needs.

**→ UNIVERSITY OF BOLOGNA**

Teaching in presence for the first year's activities and for those of the workshops, the other training activities take place at a distance.

**→ COFFEE SHOPS, RESTAURANTS AND CATERING SERVICES**

Coffee shops, pubs, restaurants, ice-cream shops, pastry shops are open to the public from 5.00 to 18.00.

Consumption at the table is allowed for a maximum of 4 people per table, unless they all live together.

Catering is allowed with home delivery in compliance with health and hygiene regulations with no time limit, and until 10 p.m. catering with take-away, with no consumption on site or nearby.

Catering in hotels is allowed without time limits only for their customers.

The consumption of food and beverages is allowed in service and refueling areas along motorways, in hospitals and airports, with the obligation to ensure that the interpersonal distance of at least one metre is respected.

Canteen and continuous catering activities are allowed, which guarantee the interpersonal safety distance of at least one metre, within the limits and under the conditions set out in the previous period.

#### ➔ PERSONAL SERVICES

The activities related to personal services are allowed according to the epidemiological situation in the territories, as verified by the regions.

The regions must identify the protocols or guidelines suitable to prevent or reduce the risk of contagion in the reference sector or similar ones.

#### ➔ GYMS AND SWIMMING POOLS

Closed gyms, swimming pools, swimming centres, wellness centres, spas, except for the essential levels of care, cultural centres, social centres and recreational centres;

Outdoor sporting and physical activity carried out outdoors at sports centres and clubs is allowed in compliance with social distancing and without any gatherings.

#### ➔ CINEMA AND THEATRES

Shows open to the public in theatres, concert halls, cinemas and other open-air spaces are suspended.

#### ➔ DISCOS

Closed dance halls, discos and similar venues, indoors or outdoors. The festivities in indoor and outdoor places are forbidden, including those consequent to civil and religious ceremonies.

#### ➔ GAME ROOMS

The activities of gaming rooms, betting rooms, bingo halls and casinos are suspended.

#### ➔ FAIRS AND CONGRESSES

Festivals, fairs and similar events are forbidden. Conferences, congresses and other events are suspended, with the exception of those held at a distance.

Public administrations provide for a differentiation of the time of entry of personnel, with the exception of health and social-health personnel and those engaged in emergency-related activities or essential public services.

Differentiation of staff entry times is also recommended by private employers.

#### ➔ PARKS AND PUBLIC GARDENS

Access is subject to strict compliance with the ban on gathering and the interpersonal safety distance of at least one metre.

#### ➔ AMUSEMENT PARKS

Theme and amusement parks are closed.

Children and young people are allowed access to places intended for playful, recreational and educational activities, indoors for outdoors, with the help of operators and with the obligation to adopt appropriate safety protocols.

#### ➔ OUTDOOR PHYSICAL ACTIVITIES

It is permitted to carry out sports or physical activities in the open air, also in equipped areas and public parks, respecting the interpersonal distance of at least two metres for sporting activity and at least one metre for any other activity, except for the presence of an accompanying person for minors or people who are not completely self-sufficient.

#### ➔ SUSPENDED THE SPORTS COMPETITIONS. THE COMPETITIVE ONES REMAIN

All sporting events and competitions are suspended, with the exception of sporting events and competitions including contact sports of national interest, training of competitive athletes concerning individual and team sports, those organised by international sporting bodies without the presence of the public.

#### ➔ MASK RECOMMENDED ALSO AT HOME BETWEEN NON-CO-HABITANTS

The use of the mask is also recommended in private homes in the presence of non-cohabitants. It is mandatory to maintain an interpersonal distance of at least one metre. It is also recommended "not to receive people other than cohabitants in the home, except for proven work needs or situations of necessity and urgency".

#### ➔ RESTRICTED ENTRANCES IN PUBLIC PREMISES

It is compulsory in public premises open to the public, in all commercial establishments, to display a sign at the entrance showing the maximum number of people admitted to the premises at the same time.

#### ➔ PLACES OF WORSHIP

Access to the places of worship takes place without the gathering of people, and ensuring the possibility of respecting the distance of at least one metre between visitors. Religious services with the participation of people take place in accordance with protocols.

**→ EXHIBITIONS/MUSEUMS/LIBRARIES**

Closed museums, archives, libraries, exhibitions and other cultural institutes and places of culture.

**→ SHOPPING CENTRES**

Shopping centres and markets are closed on public holidays and before holidays, with the exception of pharmacies, parapharmacies, healthcare facilities, food outlets, tobacco shops and newsagents.

**→ PUBLIC TRANSPORT**

Passengers on local and regional public transport, excluding dedicated school transport, may not exceed 50% of the total.
