LAW 18th December 2020 nr. 173

On 20 December shall enter into force the L. 173/2020 of conversion of the DL 130/2020.

Contains important changes in immigration legislation.

Reaffirms the centrality of the Reception and Integration System (Sai-Siproimi) within the national reception system and provides for the convertibility of numerous residence permits in the presence of the requirement for work purposes, reducing their precariousness.

CONVERSIONS

In particular, it will be possible to convert the following types of residence permits into work permits that previously could not be converted:

- Special protection (two-year duration and no longer annual)
- Calamity
- Child care
- Sporting activity
- Work of an artistic nature
- Religious reasons
- Elective residence
- Pending acquisition of citizenship
- Medical care

For the conversion of the residence permit of unaccompanied foreign minors at the age of 18, the principle of silence applies with reference to the opinion of the Committee on foreign minors.

REGISTRATION WITH THE REGISTER OFFICE

The right of asylum seekers to be registered and to have their identity card issued is explicitly confirmed.

RECEPTION AND INTEGRATION SYSTEM (SAI)

The Reception and Integration System (SAI) ex Siproimi/Sprar, will also be able to accommodate asylum seekers, for whom important services are again planned important services such as Italian language teaching (at least A1 QCER level) and the psychological support.

The Sai projects will therefore be able to accommodate, in addition to citizens with international protection and unaccompanied foreign minors, asylum seekers and minors entrusted to the social services when they reach the age of majority, if the following administrative provisions have been adopted for them pursuant to art. 13, c.2, of L. 47/2017.

In addition, if without access to dedicated protection systems, can be welcomed holders of residence permits for:

- special protection, except of special cases of exclusions;
- for medical treatment;
- social protection;
- domestic violence;
- calamity;
- particular labour exploitation;
- acts of particular civil value;
- special cases.

DURATION OF CITIZENSHIP PROCEDURE

The term for defining the procedures for granting citizenship (Articles 5 and 9 L.91/92) is reduced from 48 to 24 months, extendable up to 36 months maximum.

EXPULSION

Finally, the law underline explicitly the right to the respect for the private and family life of a person for the purposes of the assessing of the rejection or expulsion.

Expulsion of a person may not be ordered if:

- there is a risk that the person will be subjected to torture or inhuman or degrading treatment;
- in case of constitutional or international commitments of the Italian State are met;

and after careful assessment case by case (no automatism) on:

- the nature and effectiveness of family ties;
- effective social inclusion in Italy;
- the length of the person's stay in Italy;-
- the existence of family, cultural or social ties with the country of origin;

without prejudice to national security, public order, public safety or health protection.
