REGIONAL FUND FOR ACCESS TO RENTED DWELLING AS PER ART. 38 and 39 OF REGIONAL LAW N.  
24/2001 AND CC.MM.II - REGIONAL RESOLUTION N. 2031 DATED 28/12/2020

to apply for grants of contribution for the payment of rent

- for the Municipalities of **Bassa Romagna**: Alfonsine, Bagnacavallo, Bagnara, Conselice, Cotignola, Fusignano, Lugo, Massa Lombarda, S. Agata
- for the Municipalities of **Romagna Faentina**: Brisighella, Casola Valsenio, Castel Bolognese, Faenza, Riolo Terme, Solorolo
- for the Municipalities of **Cervia - Ravenna - Russi**

The admitted applications will be placed in two different rankings:

- 1<sup>st</sup> - Family group with **ISEE between 0,00 and 17.154,00 Euro**
- 2<sup>nd</sup> - Family group with **ISEE between 0,00 and 35.000,00 Euro** which suffered losses or significant decrease in household income caused by the emergency COVID-19 in the quarter of March-May 2020, also assignees of a Public Residential Housing.

The maximum grant is a fixed sum equal to 3 monthly fees for a for a maximum amount of 1.500.000 Euro.

It is possible to submit one application only per household.

Documentation to be **attached online**: **Identity document (or residence permit for non-EU countries)**, **ISEE certificate** and **rental agreement including receipt of registration and extension**

For those who apply for the **2<sup>nd</sup> ranking (drop in income above 20%)** will also serve the **pay slips** (or other documents certifying the income received) in the months **MARCH APRIL and MAY 2019** and **MARCH APRIL and MAY 2020**.

You must also have the **tax code** with you, **IBAN**, your own **e-mail address** and the **amount of the condominium expenses**.

The following conditions of the ISEE household are excluded from the contribution:

- 1) to have had in the same year 2021 the concession of a contribution of the Fund for the housing emergency deriving from the Resolutions of the Regional Executive, n. 817/2012, 1709/2013, n. 1221/2015 and n. 2365/2019
- 2) having had the same year 2021 the grant of a contribution from the Fund for **non-guilty defaulting** tenants referred to in art. 6, comma 5, of D.L. 31/07/2013, n.102 converted with Law of 28/10/2013, n. 124
- 3) **to be an assignee**, limited to the application for Ranking 1, of a **Public Residential Housing** at the time of submission of the application
- 4) to be a beneficiary, at the time of submission of the application, of the **reddito di cittadinanza or pension di cittadinanza** referred to in Decree-Law no. 4/2019 converted with amendments by Law no.26/2019
